1. DEMAROON NOT INFORMED OF THIS REQUEST BUT AGREE IN PRINCIPLE. THEY SHOULD NOT BE APPROACHED. THEY DO NOT WANT KNOW DETAILS AND CANNOT BE EXPECTED RESPOND FAVORABLY TO DIRECT APPROACHES.

2. HIS LETTER OF TWENTY FOUR SEPTEMBER TO IDENTITY TWO SEND BY [] AND BASIC REQUEST WILL BE GIVEN SYMPATHETIC CONSIDERATION.

3. AS TO HIS PROPOSALS IN DIRECT RELATIONSHIP TO OTHER SITUATION OF WHICH HE IS AWARE APPRECIATE COOPERATION DEEPLY AND REQUEST THE FOLLOWING OF IDENTITY ONE:

A. AUTHORITY TO SHIP TO HIM OR HIS REPRESENTATIVE FOR USE OF IDENTITY THREE EQUIPMENT MANIFESTED AS FARM MACHINERY AND PARTS FROM [] COMPANY EIGHT ONE TONS FOUR EIGHT HUNDRED CUBIC FEET LEAVING NEW ORLEANS THIRTEEN OCTOBER ON MOTOR SHIP LEON AND ARRIVING [] OR [] SEVENTEEN OR EIGHTEEN OCTOBER.

B. IF EAST COAST DELIVERY NOT ACCEPTABLE WEST COAST DELIVERY POSSIBLE

C. TIGHTEST SECURITY AND PROTECTION TO BE MAINTAINED ON THIS SHIPMENT BEFORE AND AFTER ARRIVAL.

4. BECAUSE OF HIS KNOWLEDGE AND EXPERIENCE IDENTITY ONE MAY BE ABLE SUGGEST ADDITIONAL MEANS OF STRENGTHENING EFFORT.

6. ANY SUGGESTION OF OVERT INVASION BY OUTSIDE NATION MUST BE AVOIDED.

7. EARLIEST POSSIBLE REPLY ON SHIPMENT ESSENTIAL.
